ALTERNATIVE RECOMMENDATION

That the Council:

- 1. Retain and re-affix 'pot plants' to the dedicated pedestrian and cyclist area/path on Hannay Lane as soon as practicable to improve safety and clearly delineate the path as a no parking area.
- 2. Request the CEO to investigate the following options for the future of Hannay Lane during the 2024/2025 financial year:
 - a. retaining two way traffic flow and constructing a kerbed raised footpath;
 - b. one way traffic flow retaining the at grade footpath with the potential of an additional loading zone; and
 - c. one way traffic flow constructing a kerbed raised footpath with the potential of an additional loading zone.
- 3. Request the CEO to provide a report to the Council on the outcome of the above investigation, including expected costs, in advance of the adoption of the 2025/2026 budget.

REASONS FOR ALTERNATIVE

Reduction to the speed limit to just 10kph already identifies the volume of usage via this laneway by pedestrians and cyclists and in so doing addresses our commitment to safe roads network with alignment with Key Theme 2 of the City's Strategic Community Plan – Lifestyle

It has already been proven that the potted plants put in place to separate dual paths from traffic has not been successful in the past and has resulted in it being uninviting and cluttered in appearance as well as creating traffic flow disturbance and opportunity seen for illegal parking as well as ongoing pedestrian safety concerns.

The laneway provides pedestrian and cyclists with linkage to the community gathering space Djiljit Mia, Rivergum Park and alternative path connection to Gifford Rd through to old Dunsborough.

Making one way traffic flow with separation of a dual path while providing for loading zone only parking may allow for more safety for family foot traffic, increase in visitation to shops with Hannay Lane frontage, and families staying to enjoy the relaxed vibe the Djiljit Mia community gathering space instils.

OFFICER COMMENT

Officers support the proposed alternative, noting it addresses immediate safety concerns and enables potential future improvements to further enhance the functionality of Hannay Lane.

Rather than Council needing to resolve the error in discrepancy with the Terms of Reference, I would like to remove myself from the Committee in line with compliance with the Terms of Reference, leaving elected Mayor Cronin, Cr Cox, Cr Richards as members and Cr Love as deputy.

OFFICER COMMENT

Cr Kaigg's request to be removed from the Committee resolves the discrepancy between the current Committee membership and the Committee Terms of Reference. The Council can remove Cr Kaigg by an absolute majority.
