Once a cat is trapped, I acknowledge that I am legally required to immediately contact the City of Busselton **Ranger and Emergency Services on (08) 9781 0444** to arrange for it to be collected by a Ranger. Unlawful disposal of a trapped cat may result in prosecution under the *Animal Welfare Act 2002*.

I also acknowledge that a **bond payment of \$100** is payable for the use of the cat trap.  
 Note: Cash or Cheque payments will be refunded via cheque or bank transfer within 21 working days of the date of return of the trap, no cash refund is available. Credit/Debit Card Payments may be refunded to the same card the initial payment was made on, otherwise a refund will be made via cheque or bank transfer within 21 working days of the date of return of the trap.

**Failure to return the trap or if trap is damaged your bond may be retained by the City of Busselton.**

**TRAPPING GUIDELINES**

- The trap is only to be set between Sunday evening and Friday morning during weekdays to prevent the cats from being in the cage for extended periods as Rangers cannot collect animals on weekends, including public holidays.
- Bait should be placed into the rear of the trap, beyond the pressure plate.
- If the trap is occupied with a cat when checked, please leave it closed and immediately contact the City of Busselton Ranger and Emergency Services on (08) 9781 0444.
- The cat trap must be checked frequently. If a cat is trapped, it must be protected from the weather and other animals. It is suggested that a trapped cat is covered with a towel or similar and provided with water.
- If the trap is occupied with a native animal other than a cat, please ring Department of Biodiversity Conservations and Attractions (DBCA) on (08) 9752 5555 as soon as possible.
- The trap will be used in the prescribed manner to ensure laws are complied with and there is minimal risk of injury to trapped animals.
- The trap is to be placed on private property with the owner's or occupant's permission. City owned traps are not to be placed on public land.
